DECLARATION AND CONDITIONS OF ENTRY

1. I the undersigned, in consideration of and as a condition of the acceptance of my entry in this event, for myself, my heirs and executors and administrators. Hereby waive all and any claim, right or course of action which I or they might otherwise have for or arising out of life or injury, damage or loss of any description whatsoever which I may suffer or sustain in the course of or consequent upon my entry or participation in this said event.
2. Your age for the purpose of determining Division entry will be as at the advertised first day of competition.
3. This waiver, release and discharge shall be and operate separately in favor of all persons, corporations and bodies involved or otherwise engaged in the promoting or staging of this event and the servants, representatives and officers and any of them and includes, but is not limited to, The Australian Waveski Surfing Associated, and affiliated Waveski Clubs/Associations, management committees and members of the aforementioned clubs and organisations, sponsors, the various State Police Departments, respective councils, Maritime Service Board of the various States, Surf Life Saving Clubs, any officials, marshals, Medical practitioners, State Ambulance Services, St John Ambulance Service, or any other person involved in the staging, organisation or administration of the event and shall operate whether or not the loss, injury or damage is attributed to the act of neglect of any one or more of them.
